Supplementary statistics contained herein are compiled from statistical information relevant to the period prior to the start of the respective 2024 financial year provided by certain companies with their financial year end dates not falling on 31 December in their quarterly returns to the Insurance Authority. The above figures (except those by Type of Motor Vehicle and Trade Occupation) have included non-Hong Kong general business written by those companies. The statistics are provisional and unaudited, and prepared on a calendar year basis. There is therefore a possibility of amendments before the final audited figures are produced. While due care is taken in the compilation of the statistics, the Insurance Authority disclaims any warranties or representations of any kind with regard to such information.
